



**Internet Safety:**

- My passwords should be kept private and not given out to others. Your class teacher may keep a secure record of your login detail in case you forget.
- I should only access the internet sites that I have been directed to by my classroom teacher.
- I will report **anything** that makes me feel unsafe or uncomfortable or if I see others being unsafe using digital technology. I will close my iPad screen immediately and seek advice from my teacher.
- I will only use text and images from the internet, if I have permission, and I have referenced its source.
- **I will never** give out my name, phone number, address, name of school, photographs or other detail about myself or others.
- **I will never** use social media while at school.

**Caring for my iPad:**

- Leave your iPad in the allocated cover at all times.
- Leave your iPad in a locked classroom during the day.
- Drink bottles should be placed on the floor or on a separate table to where the iPad is being used.
- Do not touch another person's iPad without their permission.
- Do not use personal Apple ID accounts on the school devices as this will impact the school's ability to update apps and software via Meraki.

**Classroom Expectations: Please read the expectations and sign below to show you understand:**

- I will accept requests from my teacher to link my personal device to my teacher's Apple Classroom application
- I will only use my iPad when my teacher instructs me to do so.
- I will keep my iPad charged while at home, ready for school each day.
- I will only take photos and videos when I have been given permission.
- I will not change settings (including history) on my iPad.
- I respect others and will never use digital technology to be mean, rude or unkind.
- I will follow the *Caring for my iPad Expectations*
- I will follow the *Internet Safety* requirements
- I will not download apps to the iPad I am using in the classroom
