I agree to follow these expectations when I use my iPad at school:

Online Safety:

- I will not give out personal information including, my name, phone number, address, school, photographs or other details about myself or others.
- I will not give out my password to others, except my parents and my teachers.
- I will only access the internet sites that I have been directed to by my teacher.
- I will only use text and images from the internet, if I have permission, and I have referenced its source.
- I will report anything that makes me feel unsafe or uncomfortable. I will close my iPad immediately and tell the teacher.
- I will not use iPads to be mean, rude or unkind to other people.
- I will not take photos or videos without permission from my teacher.
- I will never use social media while at school.
- I will only use the iPad I have registered and approved with the Woodland Grove Primary School

Caring for my BYOD iPad:

- I will only use my iPad for learning as directed by the teacher.
- I will follow all instructions from the teachers when using my iPad at school.
- I keep food and drink away from where my iPad is being used.
- I will not touch another person's iPad without their permission.
- I will always keep my iPad in its cover.
- I will leave my iPad in a locked classroom during the day.
- I will not put a password on my iPad.
- I will charge my iPad while at home, ready for school each day.
- I will only take photos and videos when I have been given permission.
- I will not change the settings on my iPad, including deleting the history.
- I will leave my iPad in a locked classroom during the day.
- It is my responsibility to ensure I know where my BYOD iPad is at all times.

In order to be a responsible digital citizen, I will follow the above expectations and understand that not abiding the Woodland Grove expectations may result in me losing iPad privileges.
